ACT produced six mainstage plays, including three world premieres in 2012: First Date the musical, Uncle Ho to Uncle Sam, and Ramayana. ACT's commitment to new works is evident in the ratio of premiering stories new to Seattle, the region and the world. Ongoing programs in the Central Heating Lab included the Construction Zone new play development program, Great Soul of Russia reading series, the ACT New Play Award and Workshop, Seattle Confidential, and Short Stories Live. ACT also hosted a Live Music Month series in June and partnered with local companies, Azeotrope, Theater Schmeater, Seattle Dance Project, 14/48 Festival and more, to make the most of our unique resources in the historic building we call home. Attendance in the building exceeded 170,000.

ACT education programs reflect our commitment to the community, providing opportunities for all ages at ACT and beyond. The foundation of ACT's education programs is providing high quality arts education, giving participants the freedom to develop their creative voices in a supportive, invigorating, and challenging setting. ACT's education programs play a key role in the pursuit of new art, new thought, and a higher degree of artistic excellence. In 2012 ACT led programs connected to the Young Playwrights Program and Festival, the Apple Series and Student Matinees, Higher Learning School Connections, courses in Adult Playwriting, Acting, and Directing, and created a special internship for youth connected to Ramayana.

ACT Theatre's signature holiday production of A Christmas Carol was performed for the 37th year. Over 20,000 people see this beloved Seattle tradition in the Allen Theatre.
