ACT produced six contemporary plays in the Mainstage Season: Opening the season was the 14-week musical hit Little Shop of Horrors, produced in collaboration with the 5th Avenue Theatre. Running concurrently was a new play about the themes of the 2008 financial meltdown and the impact on everyday America with, Bethany by Laura Marks. Arthur Miller's less-often produced play, The Price, looked at an expertly crafted family drama that remains timeless. Famous authors Sam Shepard, Steve Martin, and Woody Allen short plays were combined for a summer Evening of One Acts. ACT was honored to work with writer/actor and Pulitzer Prize winner Ayad Akhtar on his recent play The Invisible Hand. Closing out the Mainstage season was the Seattle premiere of the Tony Award Winner for Best Play, Christopher

The 39th annual production of A Christmas Carol was once again the highest revenue producing show in ACT history. Each year, between the Thanksgiving weekend and the end of December, nearly 20,000 people enjoy the timeless classic, adapted by ACT founder Gregory A. Falls. Special engagements in 2014 included additional options to purchase a backstage tour.

The Central Heating Lab featured many full-scale productions as well as explorations of new works in development, including New Century Theatre Company's Tales of Wasps and Marxiano Productions' Seattle Vice. A wide variety of programming included a festival celebrating works by Beckett, Terre Haute, Groucho Returns, Ham for the Holidays, Azeoptrope, the 14/48 Festival, and new recurring series from Sandbox Radio Live, Endangered Species Project and a continuation of the Great Soul of Russia.
