Audience regrowth following the pandemic continues to be a priority for the organization, and we achieved a 45% subscription growth over the 2022-23 Season. In October 2023, ACT launched the New Works Northwest Festival featuring readings of "The History of Theatre, Part 2" by Reginald André Jackson, "Mrs. Loman is Leaving" by Katie Forgette, "Golden" by Andrew Lee Creech, "Vial Man" by Steven Dietz, and "The Sunless Scar" by Maggie Lee. This advance purchase option not only makes programming accessible to individuals with limited financial resources but also allows them to properly plan and schedule their attendance, removing barriers to experiencing live theatre. In ACT's 2023-2024, over 36% of our tickets were free or reduced price, fulfilling ACT's charitable purpose by making theatre accessible to a broad economic demographic.
