These programs allowed the theatre to engage with our audience and community and artistic partners such as Letters Aloud, Kristina Wong for Public Office (a comedy event), Until the Flood, Trial and Error Productions, eSe Teatro and The Hansberry Project, local playwrights and actors to continue to offer ACT programming such as the ACTLocal Playwright series digitally via online webinar. Seven new plays were workshopped as part of the ACTLocal program, including Yussef El Guindi's Hotter Than Egypt which will be featured as our 50th world premiere during the 2022 season Mainstage season.

The PPP funds also assisted ACT in producing A Christmas Carol for the 45th year as a digital radio program. A Christmas Carol was also made available to audiences free with two over-the-air public radio broadcasts. The audio presentation meant that A Christmas Carol was available to enjoy many audiences who had not traditionally been part of our patron-base, including out-of-town patrons.
